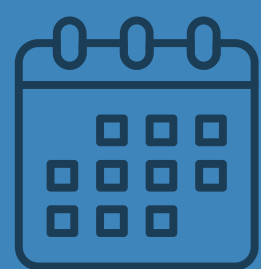

Group Discussion Rules
