North Country Health Consortium (NCHC), founded in 1997, operates as a regional partnership focused on improving the health status of Northern New Hampshire through coordinated efforts with health and human service providers. NCHC works to reduce health disparities and strengthen systems of care across this rural region.

NCHC advanced its mission through strategic growth and innovative programming in response to evolving community needs. As the demands of the COVID-19 pandemic subsided, the organization expanded its focus to include workforce development, substance use prevention and recovery, public health emergency preparedness, and initiatives addressing the social determinants of health.

In 2023, NCHC launched a new service initiative. NCHC received Opioid Abatement Funding to support North Country youth impacted by the opioid epidemic. This initiative provides school and community based supports with a strong emphasis on social-emotional learning (SEL) in educational settings.

Form 990, Part III, Line 4a, Program Service Accomplishments:

NCHC's work continues to receive recognition at both the state and national levels for its collaborative, community-centered approach. Grounded in data-driven planning, NCHC aligns its services with the region's Community Health Improvement Plan to ensure responsive, impactful, and sustainable outcomes.

Workforce Education & Training:

In FY2023, North Country Health Consortium (NCHC) reinforced its commitment to workforce development, particularly through expanding the Community Health Worker (CHW) program. Two CHW training cohorts were completed, graduating 47 CHWs with competencies in chronic disease management, substance use disorder, and the social determinants of health. Additionally, a statewide CHW awareness campaign was launched using radio, digital marketing, and public transportation signage to elevate awareness of the CHW profession.

NCHC convened a statewide CHW stakeholder committee that meets monthly

to identify and evaluate sustainable reimbursement mechanisms for CHW services. NCHC also collaborated with New Hampshire Healthy Families on a care coordination pilot to provide targeted case management services to 20 managed care members per month.

Serving as the Northern New Hampshire Area Health Education Center (NNH AHEC), NCHC continued to facilitate rural-focused professional development and pipeline initiatives. In FY23, NNH AHEC delivered continuing education to over 1,700 professionals, supported 182 high school students through career exploration programming, and hosted 19 students during the North Country Scholars Weekend. The center also launched an Advisory Council of 14 health professionals to inform strategic planning and educational alignment.

Substance Misuse and Prevention:

In alignment with regional substance misuse prevention goals, NCHC coordinated programming across the full continuum of care prevention, early intervention, treatment, and recovery. The organization facilitated 318 substance use disorder training events and played a leadership role in promoting recovery-friendly workplaces, resulting in six North Country employers adopting Recovery Friendly Workplace designation.

The "North Country Recovers Together" regional workgroup was launched to convene quarterly, engaging multi-sector stakeholders to address challenges such as housing instability, transportation, and mental health support for those in recovery.

As the lead contractor for the Grafton County Drug Treatment Court, NCHC supported 32 participants in FY2023, celebrating 6 program graduations. Additionally, harm reduction efforts included the distribution of 250 SaveOneLife kits containing naloxone and related supplies, along with the installation of 55 Naloxboxes across the region.

In partnership with Legal603, NCHC organized its first annulment clinic, helping 9 individuals receive legal assistance to expunge criminal recordsan important step toward securing housing and employment.

Community/Public Health Program:

In FY2023, NCHC expanded its public health initiatives to strengthen emergency preparedness, climate resilience, and community-wide health planning. Through the Public Health Emergency Preparedness (PHEP) program, NCHC conducted or participated in 220 trainings and events, distributed over 3,000 COVID-19 test kits, and deployed emergency supplies to regional warming shelters.

NCHC updated its Community Health Assessment (CHNA) and finalized a new Community Health Improvement Plan (CHIP) outlining a 3-year strategy to address identified health priorities, including chronic disease, oral health, behavioral health, and health equity. The CHNA was informed by subregional needs assessments, ensuring that data reflected the unique demographics of Northern New Hampshire.

Start staff and families in multiple communities, facilitated a resident-focused session at Maple Lodge (a transitional housing program for adults with mental illness), and supported school-based oral health programming in partnership with the NH Oral Health Coalition.

NCHC engaged with state and federal policymakers throughout the year to highlight the role of regional public health systems and advocate for policy that supports community resilience, particularly in underserved rural areas.
