MPNHA FY2018 STATEMENT OF WORK-Full Appropriation

The MPNHA engages in interpretation, preservation, economic development, trails development, administration, planning, development, marketing/outreach, and education within five heritage districts.

This Task Agreement contains project funding for:

A. Subrecipient Projects:

Subrecipient: Kane County

Kane County Restoration project for Carnegie Library in Kanab Total Project Cost \$37,000

Federal Funding: \$15,000

Matching Funds: \$22,000

This project will restore the exterior of the historic Kanab Library, which serves as the city's heritage museum and contains important artifacts and documents. The library restoration is part of a city/county effort to create the Kanab Center that will be developed adjacent to the library for a total budgeted cost of \$2 million.

Components of the library restoration include pressure washing to remove stains on all sides of the building, replacing deteriorated bricks, repoint masonry work and related exterior work. Section 106 review will be followed.

Subrecipient: Fremont Daughters of Utah Pioneers

Fremont School Bell Project

Total Project Cost: \$10,000

Federal Funding: \$5,000

Matching Funds: \$5,000

In 1877 Fremont became the first settlement in an area called Rabbit Valley. During the 1893 national recession, a town store had to close, and the owner deeded the building to Fremont Town. The building became a school house and in 1895 a bell was purchased and installed. The building was demolished in 1961 and the bell disappeared. Eventually, the 250 pound bell was located in California. Leah McGinnis, Superintendent of Capitol Reef National Park, worked with local historians to have the bell returned to Fremont. The local chapter of the Daughters of Utah Pioneers has raised funds to restore bell and reinforce the structure to house it. It will be located in the historic Fremont Park.

Historic Presbyterian Church Building Project

Total Project Cost: \$9,000

Federal Funding: \$4500

Matching Funds: \$4500

The American Legion owns this building and over the years they have restored and renovated it in coordination with SHPO. This project consists of replacing a 28 year old furnace with a new one,

including air conditioning. They have filled on the SHPO form and are working with Chris Hansen, Utah Division of State History in compliance with the Section 106 review.

Daughters of Utah Pioneers, Wayne County, Project Total Project Cost: \$8,000

Federal Funding: \$4,000 Matching Funds: \$4,000

This project focuses on compiling, recording, categorizing and digitizing the history of Wayne County. The Wayne County Historical Society has received permission from all of the county DUP camps to compile, record, categorize, digitize and update the history of Wayne County for free distribution through pamphlets and other means in its centers and various public venues to share the county's pioneer past and heritage.

Discovery Road TV and Education Series Total Project Cost: \$86,295

Federal Funding: \$43,095 Matching Funds: \$43,200

This is an on-going TV series that tell the story of Mormon pioneer heritage. Funding includes research, writing, archival acquisition, camera and lighting packages, audio, ancillary equipment, editing, music and post production.

Subrecipient: Richfield City

Richfield City Old Spanish Trail Silhouettes Project Total Project Cost: \$8,210

Federal Funding: \$4,105 Matching Funds: \$4,105

This project places Old Spanish Trail Silhouettes on Richfield's Centennial Park, located on North Main Street.

Subrecipient: Marysvale Town

Marysvale Historic Outdoor Dance Hall Restoration Total Project Cost: \$140,000

Federal Funding: \$47,000 Matching Funds: \$93,000

This outdoor dance hall is over 80 years old and was used during the era of big bands and the national craze for dancing outdoors. Project work includes reinforcing courtyard walls, stage restoration, electrical and plumbing. Section 106 review is in place.

Subrecipient: Garfield County

Garfield County Historic Grandstand Restoration Total Project Cost: \$10,000

Federal Funding: \$4,000 Matching Funds: \$6,000

The Garfield County Fairgrounds is listed on the National Register of Historic Places. The grandstand roof needs repair. A contractor estimate for repairing the roof of this historic structure is \$10,000. Section 106 review is in place.

Subrecipient: Wayne County

DUP/Wayne County Building and Records Restoration Project Total Project Cost: \$8,000

Federal Funding: \$4,000 Matching Funds: \$4,000

This is an important and historic building in Wayne County. DUP volunteers operate and maintain it. This project consists of building repairs, historical artifacts preservation and records recovery. Section 106 will apply to the building restoration part of the project. We will work with SHPO.

**Arapeen Trail Project Sanpete County and Manti LaSal National Forest trail work
Total Project cost: \$10,600**

Federal Funding: \$5300 Matching Funds: \$5300

This project continues trail improvements on 5.5 miles of Arapeen trail #42. Partners include national forest staff and Sanpete County Office of Travel and Economic Development.

Subrecipient: Sanpete County

Sanpete County Fairgrounds Project Total Project Cost: \$160,000

Federal Funding: \$30,000 Matching Funds: \$130,000

The Sanpete County Fairgrounds is home to a traditional county fair that promotes agricultural events that are important to the heritage of the county, region, and MPNHA. It augments the agri-tourism functions that take place in the Cleone Peterson Eccles Equestrian Center in Mt. Pleasant. This project consists of enhancing fairground facilities for large and small animal venues as well as agricultural products.

Subrecipient: Casino Star Theatre Foundation

Casino Star Theatre Project Total Project Cost: \$92,000

Federal Funding: \$20,000 Matching Funds: \$72,000

The Casino Star Theatre is a beautifully restored historic building that functions as an active movie theater and also hosts plays and concerts. Extensive restoration work has been completed in coordination with the SHPO. The work is guided by the Casino Star Theatre Foundation, a non-profit corporation. This phase of restoration consists of replacing 265 theater seats that are totally worn out and can no longer serve the public.

Palisade Park Bike/Hike Trail Total Project Cost: \$18,000

Federal Funding: \$9,000 Matching Funds: \$9,000

The project will widen and improve a 1.2 mile trail and construct a new loop. In addition to trail construction, kiosks, signs and benches will be erected.

Subrecipient: Mt. Pleasant City

Mt. Pleasant Bike Path

Total Project Cost: \$207,000

Federal Funding: \$7,000 Matching Funds: \$200,000

The Bike path will begin at the historic railroad depot on Highway 89. It will be alongside the highway, and work its way toward the historic town of Spring City.

Subrecipient: Wasatch Academy

Wasatch Academy Craighead Vocational Building Renovation Total Project Cost: \$180,000

Federal Funding: \$15,000 Matching Funds: \$165,000

Wasatch Academy's campus, including many historic buildings, is listed on the National Register of Historic Places. The Academy has received numerous awards from Preservation Utah and the Utah Division of State History for its restoration work. This particular project focuses on completing exterior and interior restoration/renovation. The contractor is working closely with SHPO.

Subrecipients: Wayne County

Torrey Apple Growing Heritage Project

Total Project Cost: \$20,000

Federal Funding: \$10,000 Matching Funds: \$10,000

The towns of Torrey and Fruita have a heritage of growing apples. Capitol Reef National Park invites visitors to pick apples and they sell apple pie in the gift store. This project consists of working with the Wayne County Travel Council to do an inventory of the apple trees and to conduct a community juicing day.

Subrecipient: Spring City

Spring City Veterans Memorial Project

Total Project Cost: \$28,000

Federal Funding: \$14,000 Matching Funds: \$14,000

The entire town of Spring City is listed on the National Register of Historic Places. Preservation and interpretation are highlighted through heritage projects. A veteran's memorial will convey the city's heritage of military service. More than 500 individuals have been identified for inclusion in the memorial, beginning with the Mormon Battalion of 1847 during the war with Mexico. The Battalion served as a nucleus for Mormon colonization in California

Subrecipient: Mt. Pleasant CDRA

Historic Denver Rio Grande Project

Total Project Cost: \$13,000

Federal Funding: \$6,000

Matching Funds: \$7,000

Depot restoration has been completed. Boxcar restoration is 90% completed. This grant will wrap up car restoration and enhance the area around the depot, including landscaping to make the project a highly attractive heritage tourism experience.

Subrecipient: Sanpete County Certified Local Government

Historic Buildings Restoration Project

Total Project Cost: \$26,000

Federal Funding: \$6,000

Matching Funds: \$20,000

The Sanpete CLG has received a \$10,000 grant from the Utah Division of State History. This grant will provide matching funds for façade restoration on historic buildings on Mt. Pleasant City Main Street and the Historic Staker House. Section 106 Review is in place. Building owners will provide 50% in matching funds. CLG grant funds will not be used as a match. In addition to building owner funds, Sanpete County is providing small façade grants. Don Hartley, an architect with the Utah Division of State History, has inspected the buildings that will qualify for grant money.

Heritage Events

Total Project Cost: \$12,000

Federal Funding: \$6,000

Matching Funds: \$6,000

The MPNHA management plan cites the role events play in conveying Mormon heritage. Subrecipients receive matching funds for their events by submitting a proposal and linking the event to the management plan and showing how heritage tourism or Mormon pioneer artisanship, art and/or crafts are enhanced by the event. MPNHA policy limits a heritage event grant to \$1,000 per event, unless a waiver is granted. All grants require a 50% match.

Kanab Heritage House Historic Barn Project

Total Project Cost: \$23,000

Federal Funding: \$8,000

Matching Funds: \$15,000

The City of Kanab wants to build a historic period barn adjacent to the Kanab Heritage House in Kanab. The city has \$15,000.00 in a cash match to contribute to the project plus another \$10,000 in-kind to build the barn with work performed by the City of Kanab. We are requesting \$8,000 in matching funds from the Mormon Pioneer National Heritage Area, which would enable Kanab City to build the barn. The total cost of constructing the barn is estimated to cost \$33,000. The size of the barn will be 33'x22'x14'. We are coordinating with SHPO on review.

MORMON PIONEER NATIONAL HERITAGE AREA
WORK PLAN FOR FY2019-FULL APPROPRIATION**

The MPNHA engages in interpretation, preservation, economic development, trails development, administration, planning, development, marketing/outreach, and education within five heritage districts.

This Task Agreement contains project funding for:

A. Subrecipient Projects

Subrecipient: Wayne County

Wayne County Teasdale Restoration Project

Total Project Cost: \$125000 Federal Funding: \$20000 Matching Funds: \$105000

In collaboration with Wayne County, the Teasdale Historic Society formed a 501(c)(3) non-profit organization with the goal of restoring and preserving a historic dance hall building. The building will need structural improvements, as well as interior and exterior restoration. According to the National Register of Historic Places requirements, the building is eligible to be listed. Funding will be used towards the purpose of restoration so the community will not lose its remaining iconic structure. The building is currently vacant, but upon restoration will be used as a community center. Section 106 will follow.

Subrecipient: Garfield County

Garfield County Historic Fairgrounds Restoration Project

Total Project Cost: \$78900 Federal Funding: \$20000 Matching Funds: \$58900

The outdoor rodeo grounds of Garfield County's historic fairgrounds in Panguitch City are the intended recipient of long overdue restoration efforts to see that the cherished local rodeo and agri-tourism traditions that are important to the city, county, region, and MPNHA carry on. This project consists of restoring the announcer's stand and pens for calves and bulls. The city will work with the Utah Division of State History, though it's unlikely that Section 106 review will apply.

Subrecipient: Kane County

Kane County Trails Kiosk Project

Total Project Cost: \$90,000 Federal Funding: \$3000 Matching Funds: \$87000

Kane County is refinishing a historic trail along an area steeped in local folklore that was once inhabited by two brothers, the Greenhalph brothers. The brothers raised and grazed cattle, running them along the areas near the trail and had a cabin there, as well. To commemorate the brothers' history, the county is naming the trail after them, and the funding will go to erect an interpretive kiosk which will tell the Greenhalph tale to the travelers who traverse the soon-to-be-completed historic Greenhalph trail.

Discovery Road TV Series

Total Project Cost: \$61212 Federal Funding: \$30000 Matching Funds: \$31212

This is an ongoing TV series that tells the story of Mormon pioneer heritage. Funding includes research, writing, archival acquisition, camera and lighting packages, audio, ancillary equipment, editing, music, and post production.

Subrecipient: Casino Star Theatre Foundation (CSTF)

Historic Casino Star Theatre "Take a Seat" Project

Total Project Cost: \$105564 Federal Funding: \$20000 Matching Funds: \$85564

The "Take a Seat" Project will replace the 265 seats in the auditorium with seats that replicate the original burgundy seats from the 1930's. The new vintage-styled seats will complement the auditorium's historic elegance. The seats will be comfortable, quiet, have cup holders, wood arm rests, seat numbers for reserved seating, inset brass plates for donor names, and decorative aisle stands. The new seating will also allow the theatre to better accommodate handicapped patrons. When the old chairs are removed, we will preserve and repair the 106-year-old red oak floor.

This project is long overdue. The current seats are bright orange and were acquired in the 1970's from a BYU classroom. These ugly, bright orange, worn and torn seats with a lift up desk, squeak loudly during the quiet moments of movies and live performances. The drinks and popcorn fall off the tilted desks. The seats are uncomfortable and beyond repair as we tape off one or two chairs per month and place them out of service when the seat mechanism breaks.

The Project is underway with anticipated completion by September, 2019.

Bishop's Storehouse project

Total Project Cost: \$68000 Federal Funding: \$30000 Matching Funds: \$38000

The historic Ephraim City Bishop's Storehouse project will involve masonry repairs for an estimated total of \$41000 and window repairs for an estimated total of \$27000, equaling \$68000 total project cost estimate. Section 106 will be coordinated with the SHPO office.

Subrecipient: Manti City

Historic Manti City Hall

Total Project Cost: \$3000 Federal Funding: \$1500 Matching Funds: \$1500

The Historic Manti City Hall (circa 1882) is on the National Register. Additional rain gutter will be installed to protect the oolite limestone foundation from water damage.

Subrecipient: Bicknell Town

Wayne County Heritage Park project

Total Project Cost: \$40000 Federal Funding: \$18000 Matching Funds: \$22000

Bicknell Town is proposing to build a Wayne County Heritage Park on main street property recently donated to Bicknell Town by a private individual. Total project cost is \$40,000. Bicknell Town is seeking funds in the amount of \$18,000 for site work, landscaping and local Heritage information kiosks. Bicknell Town, its residents, and local contractors have agreed to provide construction materials and labor for this local Heritage project.

Subrecipient: Tropic town

The Scout House project

Total Project Cost: \$60000 Federal Funding: \$25000 Matching Funds: \$35000

Scout House was built in the 1920/1930's and is located at the Town Park and is still being used today. Funds will be used to restore the foundation, logs and windows in the building. Section 106 will be coordinated with the SHPO office.

Subrecipient: Sanpete County

Sanpete Trails project

Total Project Cost: \$60000 Federal Funding: \$30000 Matching Funds: \$30000

Partnering with public land agencies to improve outdoor recreation in Sanpete County. Proposed projects include a 66" wide bridge for Arapeen OHV Trail #38 east of Sterling, OHV route improvements and infrastructure, and restroom(s). Additional in-kind donations of equipment and labor anticipated from public land agencies.

Subrecipient: Garfield County

Highway 12 Brochures

Total Project Cost: \$32882 Federal Funding: \$10000 Matching Funds: \$22882

Garfield County would like to apply for a \$10,000 grant to help with the reprint of the Highway 12 brochures. The bid to reprint 100,000 brochures is \$32,882 with the Garfield County Travel Council paying \$20,000 toward that cost. The remaining cost of \$2,882 will be covered by communities along Highway 12. The MPNHA logo will be placed on the back of the brochure. These brochures are given out at travel shows by the Garfield County Travel Council.

Moroni Veterans' Memorial

Total Project Cost: \$67000 Federal Funding: \$5000 Matching Funds: \$62000

Moroni City, in the ongoing project of developing a Veterans' Memorial, now has put together 677 names, including 143 Blackhawk War (1865-1872) names and 534 other combined service names. These are the men and women from Moroni City. These names will be put on a black granite stone 7' long x 3' tall x 8' thick monument with a matching base. The names will be

laser engraved on both sides of the granite block with room for approximately 50 more names who can be added to the stone in the future.

Daughters of Utah Pioneers Project

Total Project Cost: \$10000 Federal Funding: \$4000 Matching Funds: \$6000

Wayne County, in conjunction with the Daughters of the Utah Pioneers (Wayne County Chapter) has the unique opportunity to compile, publish, and produce its local histories and bind them into a book.

Subrecipient: Mt. Pleasant City

Mt. Pleasant Depot project

Total Project Cost: \$21500 Federal Funding: \$10000 Matching Funds: \$11500

This is a continuation of the public/private partnership for the Track 89 railroad depot project in Mt. Pleasant, Utah. This project consists of additional landscaping around the historic Rio Grande Depot and the Caboose that was used on the construction of the Hoover Dam.

Subrecipient: Marysvale Town

Mining Museum project

Total Project Cost: \$40000 Federal Funding: \$20000 Matching Funds: \$20000

This project consists of establishing a mining museum that reflects the historic role that mining played in the settlement of Marysvale. The Historical Society has collected artifacts and memorabilia that will be placed in the building along with the digitization of oral histories and photographs. The museum will also serve as a visitors' center. Funding for this project will be for work on the interior of the museum, to display the artifacts, and other artifacts, memorabilia, and other materials to help interpret the mining history of the town.

Stud Horse Point trail project

Total Project Cost: \$81,950 Federal Funding: \$20,000 Matching Funds: \$61,950

Kane County and Glen Canyon National Recreation Area (GCNRA) are developing a non-motorized trail system at Stud Horse Point, located in eastern Kane County near the town of Big Water, Utah, located on Glen Canyon National Recreation Area administered land. The site is conveniently accessed from US 89 and is already a popular destination. The area is known as Stud Horse Point, known for its sheer cliffs, photogenic sandstone formations, and ravines lined with large hoodoos, composed of dark brown, partly conglomerate boulders on top of green and red pedestals. The Stud Horse Point mesa is also home to the spectacular Skyline Arch and iconic views of the surrounding cliffs and green-blue water of Lake Powell visible in the distance.

Wayne County Fairgrounds Project

Total Project Cost: \$200000 Federal Funding: \$20000 Matching Funds: \$180000

The grounds of Wayne County's historic fairgrounds have need of long overdue improvement efforts to ensure fairground events and agri-tourism traditions that are important to the city, county, region, and MPNHA will continue.
